1 2013 Operating and Capital Budgets

January 2, 2013, recommending that:

- 1. Approve the 2013 budget and 2014 outlook, as amended by this report and as summarized in *Attachments 1 and 2*.
- 2. Approve reallocation of capital budget from 2012 to 2013 Capital Spending Authority as summarized in *Attachment 3*.

- 3. Approve the 2013 Capital Spending Authority and incremental 2014 Capital Spending Authority outlook, as amended by this report and as summarized in *Attachments 4 and 5*.
- 4. Approve a policy to increase the annual contribution to the Capital Asset Replacement reserve by a further 0.2% per year until it reaches 2% of the annual tax levy.
- 5. Approve the debt authority required for the 2013 Capital Spending Authority as specified in *Attachment 6*;
- 6. Authorize the Commissioner of Finance and Treasurer to:
 - a) Issue long-term debt financing for the projects up to the amounts specified in *Attachment 6* in accordance with the Capital Financing and Debt Policy;
 - b) Enter into bond forward agreements to reduce interest rate exposure for up to 75% of the debt financing identified above where, in the opinion of the Treasurer, economic benefits could be achieved;
 - c) Fund projects that have been previously approved for tax levy debt financing from debt reduction funds where, in the opinion of the Treasurer, it is prudent to do so; and
 - d) Make any necessary adjustments within the total approved budget to reflect organizational changes, adjustments and any other reallocation of costs.
- 7. Adopt the Long-Term Debt Management Plan that forms *Attachment* 7 of this report.
- 8. Endorse *Attachment 8* as required under Ontario Regulation 284/09

2 Property Taxes on Leased Properties

December 6, 2012, recommending that:

- 1. Council authorize staff to negotiate Municipal Capital Facilities Agreements (MCFA) for all leased administrative sites with property taxes greater than \$10,000.
- 2. The Commissioner of Corporate Services or his designate be authorized to sign the MCFAs with the Region's landlords.

3 2013 Interim Tax Levy

November 21, 2012, recommending that:

- 1. The 2013 interim tax levy for local municipalities shown in Table 1 be approved.
- 2. The interim tax levy be payable in two equal installments, the first of which will be due on or before April 30, 2013 and the second due on or before June 28, 2013, as shown in *Council Attachment 1*.
- 3. The Regional Solicitor be authorized to prepare the necessary bylaw to give effect to these recommendations.

4 Sinking and Retirement Fund Requirements for 2013

December 6, 2012, recommending that:

- 1. Council approve the \$100,887,118 included in the 2013 Budget for the purpose of meeting the Region's sinking and retirement fund obligations.
- 2. The Regional Solicitor be authorized to prepare amending bylaws to reflect the increases in annual contributions required for those debentures shown in Table 2 of this report.
- 3. The Township of King and the City of Vaughan be notified of the changes to the contributions required as it pertains to their debentures under the pertinent bylaws.
- 4. The Township of King be notified of a contribution shortfall of approximately \$10,000 in 2012 with respect to debenture bylaw #D-0188-2007-049.

5 York.ca Website Technical Implementation Procurement

December 13, 2012, recommending that:

- 1. Council authorize the retention of the consulting firm of Partho Technologies Inc. to undertake the technical implementation of York Region's public facing external website (York.ca), at a cost not to exceed \$510,368.40, exclusive of HST.
- 2. Council authorize the execution of the contract, subject to terms and conditions acceptable to the Commissioner of Finance and approval of Legal Services.

6 Abandonment of Expropriated Land Township of King

December 6, 2012, recommending that:

- 1. Subject to the former owners executing the required election to take back the hereinafter described lands, Council abandon a portion of the fee simple interest, described as Part 1 on Expropriation Plan YR1856888, subsequently described as Part 1 on Reference Plan 65R-33846 and retain a fee simple interest in the 1,130.25 square feet of land described as Part 2 on Reference Plan 65R-33846, in the Township of King, in accordance with Section 41 of the *Expropriations Act* (the "Act").
- 2. Authority be granted for the execution of the Notice of Abandonment and the Declaration of Abandonment pursuant to Section 41 of the *Act* and the introduction of the necessary bill in Council to give effect to the foregoing.
- 3. The appropriate Regional Officials perform all acts necessary to give effect to the foregoing.

7 Expropriation Settlement 425 and 431 Davis Drive, VIVA Project 90991 Town of Newmarket

December 14, 2012, recommending that:

- Council authorize the following expropriation settlement for land expropriated for the vivaNext Davis Drive project, in the Town of Newmarket, on the terms set out in this report, subject to the approval of Metrolinx.
- 2. The Commissioner of Corporate Services be authorized to complete the transaction in accordance with the terms of the agreement upon receipt of approval of the agreement from Metrolinx.
