BY-LAW NO. 2009-16

To acquire certain lands for or in connection with
constructing the Joe Dales Forcemain
Town of Georgina

WHEREAS the Council of The Regional Municipality of York on March 27, 2008, by its adoption of Clause 9 of Report 3 of the Transportation and Works Committee and on June 19, 2008, by its adoption of Clause 25 of Report 6 of the Transportation and Works Committee approved of the expropriation of the interests in lands therein referred to for or in connection with constructing the Joe Dales Forcemain, in the Town of Georgina, provided that there were no requests for a hearing of necessity; and

WHEREAS Notice of Application for Approval to Expropriate Land has been served upon the registered owners of the interests in lands and has been published pursuant to the provisions of the *Expropriations Act*, R.S.O. 1990, Chapter E.26; and

WHEREAS no notification of a desire for a hearing has been received and the time for giving such notification has expired.

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The expropriation of the interests in lands referred to in section 2 is hereby approved and the Regional Chair and Regional Clerk are authorized to execute any required documents in accordance with the *Expropriations Act*.
2. The lands described and designated as follows:

Permanent Easement Interest:

Parts 1 and 2 on Plan 65R-30594

Parts 1 and 2 on Plan 65R-30603

Parts 1 and 2 on Plan 65R-31148

Part 2 on Plan 65R-31304

Temporary Easement Interest:

Part 1 on Plan 65R-31304 (expiring on December 31, 2010)

are hereby expropriated and taken for or in connection with constructing the following:

- (a) twin forcemains running in an easterly direction from the pumping station on Joe Dales Drive to the east side of Woodbine Avenue (YR 8) at a point 400m north of Ravenshoe Road (YR 32);
- (b) twin forcemains running in a northerly direction on the east side of Woodbine Avenue (YR 8) from 400m north of Ravenshoe Road (YR 32) to Morton Avenue (YR 78); and
- (c) twin forcemains running in a westerly direction along Morton Avenue (YR 78) from Woodbine Avenue (YR 8) to the Keswick water pollution control plant.

3. (1) The Regional Chair and Regional Clerk are hereby authorized and directed to sign a plan or plans showing the interests in lands expropriated.

(2) When so signed, the Regional Commissioner of Corporate Services is directed to cause the said plan or plans to be registered in the proper Land Registry Office and to pay all expenses incidental to the registration.

4. Plan Nos. 65R-30594, 65R-30603, 65R-31148 and 65R-31304, hereto attached, shall form part of this by-law.
