BY-LAW NO. 2010-29

To acquire certain lands for or in connection with the
widening and reconstruction of Bloomington Road (YR 40)
Towns of Aurora and Richmond Hill

WHEREAS the Council of The Regional Municipality of York on September 18, 2008 by its adoption of Clause 8 of Report 7 of the Transportation and Works Committee and on November 20, 2008 by its adoption of Clause 15 of Report 9 of the Transportation and Works Committee approved of the expropriation of the lands and interest in lands therein referred to for or in connection with the widening and reconstruction of Bloomington Road (YR 40), from Bayview Avenue (YR 34) to Highway 404 in the Towns of Aurora and Richmond Hill.

WHEREAS Notice of Application for Approval to Expropriate Land has been served upon the registered owners of the lands and interest in lands and has been published pursuant to the provisions of the *Expropriations Act*, R.S.O. 1990, Chapter E.26; and

WHEREAS one of the registered owners gave notification in writing of a desire for a hearing. Prior to the hearing taking place, agreement was reached between the registered owner and the Regional Corporation, and the Inquiry Officer rendered his decision endorsing the agreement; and

WHEREAS Regional Council on March 25, 2010, considered the decision of the Inquiry Officer and by its adoption of Clause 2 of Report 2 of the Regional Solicitor approved the expropriation of the hereinafter described lands.

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The expropriation of the lands referred to in section 2 is hereby approved and the Regional Chair and Regional Clerk are authorized to execute any required documents in accordance with the *Expropriations Act*.

2. The lands described and designated as follows:

Fee Simple Interest:

Part 5 on Plan 65R-30903

Parts 4 and 5 on Plan 65R-30904

are hereby expropriated and taken for or in connection with the widening and reconstruction of Bloomington Road (YR 40) from Bayview Avenue (YR 34) to Highway 404, in the Towns of Aurora and Richmond Hill

3. (1) The Regional Chair and Regional Clerk are hereby authorized and directed to sign a plan or plans showing the lands expropriated.

(2) When so signed, the Regional Commissioner of Corporate Services is directed to cause the said plan or plans to be registered in the proper Land Registry Office and to pay all expenses incidental to the registration.

4. Plan Nos. 65R-30903 and 65R-30904, hereto attached, shall form part of this by-law.
