BY-LAW NO. 2010-40

To dedicate certain lands for
the purposes of a public highway

WHEREAS the hereinafter described lands are vested in The Regional
Municipality of York for highway purposes;

Now, therefore, the Council of The Regional Municipality of York HEREBY
ENACTS as follows:

1. The acquisition of the lands described in Schedules “A”, “B”, “C”, “D”, “E”, “F”, “G”, “H”, “I” and “J”, hereto attached, is hereby authorized, ratified and confirmed.

2. The lands described in Schedule “A”, hereto attached, are hereby dedicated as a public highway and declared to form part of Major Mackenzie Drive West (YR 25).
3. The lands described in Schedule “B”, hereto attached, are hereby dedicated as a public highway and declared to form part of Rutherford Road (YR 73).
4. The lands described in Schedule “C” and “D”, hereto attached, are hereby dedicated as a public highway and declared to form part of Highway 7 (YR 7).
5. The lands described in Schedules “E”, “F” and “I”, hereto attached, are hereby dedicated as a public highway and declared to form part of Keele Street (YR 6).

6. The lands described in Schedules “G” and “H”, hereto attached, are hereby dedicated as a public highway and declared to form part of Bathurst Street (YR 38).
7. The lands described in Schedule “J”, hereto attached, are hereby dedicated as a public highway and declared to form part of Kennedy Road (YR 3).
8. The said Schedules “A”, “B”, “C”, “D”, “E”, “F”, “G”, “H”, “I”, and “J”, hereto attached, shall form part of this by-law.
