BY-LAW NO. 2010-49

To amend By-law No. DC-0007-2007-040, as amended

WHEREAS Section 19 of the *Development Charges Act, 1997, S.O. 1997, c.27*, (the “Act”) provides for amendments to development charge by-laws;

AND WHEREAS the Council of The Regional Municipality of York requires certain amendments to By-law No. DC 0007-2007-040, as amended;

AND WHEREAS in accordance with the Act a development charge background study has been completed in support of the increased development charges and imposition thereof through amendments to the By-law;

AND WHEREAS the Council of The Regional Municipality of York has given notice and held a public meeting on the 6th day of May, 2010, in accordance with the Act;

AND WHEREAS the Council of The Regional Municipality of York has determined that a further public meeting is not necessary pursuant to Section 12(3) of the Act;

NOW THEREFORE the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. Section 3.6.1 of By-law No. DC-0007-2007-040, as amended, is replaced with the following:

“The development charges imposed under subsection 3.6 shall be phased and payable in the amounts applicable at the date of payment as set out in the applicable Schedules B. For greater certainty, Schedules B-1 to B-6 apply to the following periods:

3. Section 3.8.1 of By-law No. DC-0007-2007-040, as amended, is amended by changing the reference to “Background Study dated March 22, 2007” to “Background Study dated April 21, 2010”.
4. Section 3.11 of By-law No. DC-0007-2007-040, as amended, is amended by changing the reference to “Schedules F-1 to F-4” to “Schedules F-1 to F-5”.
5. Section 3.11 of By-law No. DC-0007-2007-040, as amended, is amended by replacing subsection (d) with the following:

(d) Schedule F-3 June 18, 2009 to June 24, 2010

6. Section 3.11 of By-law No. DC-0007-2007-040, as amended, is amended by replacing subsection (e) with the following:

(e) Schedule F-4 June 25, 2010 to June 17, 2011

7. Section 3.11 of By-law No. DC-0007-2007-040, as amended, is amended by adding the following:

(f) Schedule F-5 June 18, 2011 to June 17, 2012

8. Section 3.13.1 of By-law No. DC-0007-2007-040, as amended, is amended by changing references to “MoveOntario 2020 Initiatives” to “Road Improvements to Support Transit Runningways”.
9. Section 3.13.1 of By-law No. DC-0007-2007-040, as amended, is amended by changing the reference to “Background Study dated March 22, 2007” to “Background Study dated April 21, 2010”.
10. Section 5.1 of By-law No. DC-0007-2007-040, as amended, is replaced with the following:

“Development charges imposed pursuant to this by-law shall be adjusted annually, without amendment to this by-law, on June 18th of each year in accordance with the Statistics Canada Quarterly Construction Price Statistics.”
11. Section 6.1 of By-law No. DC-0007-2007-040, as amended, is amended by changing the reference to “Eligible MoveOntario 2020 Initiatives” to “Eligible Road Improvements to Support Transit Runningways”.

12. Schedule B-3A of By-law No. DC-0007-2007-040, as amended, is hereby amended by replacing the effective date of “February 1, 2009 to June 17, 2012” with “February 1, 2009 to June 24, 2010”.
13. By-law No. DC-0007-2007-040, as amended, is hereby amended by the addition of Schedule “B-4” attached hereto.
14. By-law No. DC-0007-2007-040, as amended, is hereby amended by the addition of Schedule “B-5” attached hereto.
15. By-law No. DC-0007-2007-040, as amended, is hereby amended by the addition of Schedule “B-6” attached hereto.
16. Schedule F-3 of By-law No. DC-0007-2007-040, as amended, is hereby amended by replacing the effective date of “June 18, 2009 to June 17, 2010” with “June 18, 2009 to June 24, 2010”.
17. Schedule F-4 of By-law No. DC-0007-2007-040, as amended, is hereby amended by replacing the effective date of “June 18, 2010 to June 17, 2012” with “June 25, 2010 to June 17, 2011”.
18. By-law No. DC-0007-2007-040, as amended, is hereby amended by the addition of Schedule “F-5” attached hereto.
19. Schedule “H” of By-law No. DC-0007-2007-040, as amended, is hereby replaced by Schedule “H” of this by-law.
20. Schedule “I” of By-law No. DC-0007-2007-040, as amended, is hereby replaced by Schedule “I” of this by-law.
