BY-LAW NO. 2010-74

To amend By-law No. R-1102-96-100 to prohibit  
or regulate parking and stopping on Regional Roads

The Council of The Regional Municipality of York hereby enacts as follows:

1. By-law No. R-1102-96-100 is hereby amended as set out in this by-law.
2. Subsection 6.1 is hereby deleted and replaced with the following:

“6.1 Where authorized signs are displayed, no person shall park a vehicle on the highway at the side and between the limits set out respectively in Columns 1, 2, 3 and 4 of Schedule “A” to this by-law during the prohibited times or days set out in Column 5 of the said Schedule.”
3. Subsection 6.2 is hereby deleted and replaced with the following:

“6.2 Where authorized signs are displayed, no person shall park a vehicle on the highway at the side and between the limits set out respectively in Columns 1, 2, 3 and 4 of Schedule “B” to this by-law except during the hours or days set out in Column 5 of the said Schedule for a period not to exceed the time set out in Column 6 of the said Schedule.”
4. Subsection 7.1 is hereby deleted and replaced with the following:

“7.1 Where authorized signs are displayed, no person shall stop a vehicle on the highway at the side and between the limits set out respectively in Columns 1, 2, 3 and 4 of Schedule “C” during the prohibited times or days set out in Column 5 of the said Schedule.”

5. Schedule "C" is amended by adding the following:
