BY-LAW NO. 2010-81

A by-law to provide for the appointment of an Acting Chair
when the Regional Chair is absent

WHEREAS Section 242 of the *Municipal Act, 2001*, provides that a municipality may by-law appoint a member of the council to act in the place of the head of council when the head of council is absent;

NOW THEREFORE the Council of The Regional Municipality of York hereby enacts as follows:

1. If the Regional Chair is absent for any reason at any time during the current term of Regional Council, the member of Regional Council whose name appears in Column 2 of Schedule “A” attached is hereby appointed to act in the place of the Regional Chair during each such absence during the period appearing opposite his or her name in Column 1.
2. If the member whose name appears in Column 2 is also absent, the member whose name appears in Column 3 is hereby appointed to act in the place of such member during the period set out in Column 1.
3. Schedule “A” shall form part of this by-law.
4. By-law No. 2009-12 is hereby repealed.
