BY-LAW NO. 2011-13

To acquire certain lands for or in connection with
constructing the Toronto-York Spadina Subway Extension,
in the City of Vaughan

WHEREAS the Council of The Regional Municipality of York on January 27, 2011, by its adoption of Clause 7 of Report 1 of the Finance and Administration Committee and on February 17, 2011, by its adoption of Report 1 of the Commissioner of Corporate Services approved of the expropriation of the lands and interest in lands therein referred to for or in connection with constructing the Toronto-York Spadina Subway Extension, in the City of Vaughan; and

WHEREAS Notice of Application for Approval to Expropriate Land has been served upon the registered owners of the lands and interest in lands and has been published pursuant to the provisions of the *Expropriations Act*, R.S.O. 1990, Chapter E.26; and

WHEREAS a request for a hearing before an Inquiry Officer was received and subsequently withdrawn.

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The expropriation of the lands and interest in lands referred to in section 2 is hereby approved and the Regional Chair and Regional Clerk are authorized to execute any required documents in accordance with the *Expropriations Act*.

3. (1) The Regional Chair and Regional Clerk are hereby authorized and directed to sign a plan or plans showing the lands and interest in lands expropriated.

(2) When so signed, the Regional Commissioner of Corporate Services is directed to cause the said plan or plans to be registered in the proper Land Registry Office and to pay all expenses incidental to the registration.

4. Draft Plan of Survey (Project No. 09-080-12), hereto attached, shall form part of this by-law.
