BY-LAW NO. 2011-17

To dedicate certain lands for
the purposes of public highways

WHEREAS the hereinafter described lands are vested in The Regional Municipality of York for highway purposes;

Now, therefore, the Council of The Regional Municipality of York hereby enacts as follows:

1. The acquisition of the lands described in Schedules "A", "B" and "C", hereto attached, is hereby authorized, ratified and confirmed.
2. The lands described in Schedule "A", hereto attached, are hereby dedicated as a public highway and declared to form part of Langstaff Road (YR 72).
3. The lands described in Schedule "B", hereto attached, are hereby dedicated as a public highway and declared to form part of 2nd Concession Road (YR 34).
4. The lands described in Schedule "C", hereto attached, are hereby dedicated as a public highway and declared to form part of Donald Cousens Parkway (YR 48).
5. The said Schedules "A", "B" and "C", hereto attached, shall form part of this by-law.

SCHEDULE “A” TO BY-LAW NO. 2011-17

Lands in the City of Vaughan in The Regional Municipality of York, geographically in the Township of Vaughan in the County of York, and being composed of part of Lot 10, Concession 3 designated as Part 4 on Plan 65R7912.

SCHEDULE “B” TO BY-LAW NO. 2011-17

Lands in the Town of East Gwillimbury in The Regional Municipality of York, geographically in the Township of East Gwillimbury in the County of York more particularly described as follows:

Firstly: Part Lots 113 and 114, Concession 1 designated as Parts 1, 2 and 3 on Plan 65R10781;

Secondly: Part Lot 18, Concession 2 designated as Part 4 on Plan 65R10781;

Thirdly: Part Lot 19, Concession 2 designated as Parts 5 and 6 on Plan 65R10781;

Fourthly: Part Lot 101, Concession 1, East of Yonge Street designated as Part 1 on Expropriation Plan R734820; and

Fifthly: Part Lot 6, Concession 2 designated as Part 2 on Expropriation Plan R734820.

SCHEDULE “C” TO BY-LAW NO. 2011-17

Lands in the Town of Markham in The Regional Municipality of York, geographically in the Township of Markham in the County of York being part of Lot 20, Concession 8 designated as Parts 1 and 6 on Expropriation Plan D832, Part 11 on Plan 65R23103, Parts 16 and 25 on Expropriation Plan D834 and Parts 15 and 16 on Plan 65R32525.
