BY-LAW NO. D-0191-2007-081

A by-law to authorize the borrowing upon 3 year instalment debentures in the principal amount of \$25,271,000.00 and 10 year term debentures in the principal amount of \$71,520,000.00 (in the aggregate principal amount of \$96,791,000.00) for the purposes of The Regional Municipality of York

WHEREAS the *Municipal Act, 2001*, as amended (the “**Act**”) provides that a municipality may incur a debt for municipal purposes, whether by borrowing money or in any other way, and may issue debentures and prescribed financial instruments and enter prescribed financial agreements for or in relation to the debt;

AND WHEREAS the Council of The Regional Municipality of York (the “**Upper-tier Municipality**”) has authorized the undertaking of the purposes of the Upper-tier Municipality (individually a “**Project**”, collectively the “**Projects**”) set out in Column (2) of Schedule “A” attached hereto and forming part of this By-law (“**Schedule A**”) and desires to issue debentures for the Projects in the respective principal amounts specified in Column (5) of Schedule “A” over the respective terms of years specified in Column (6) of Schedule “A”;

AND WHEREAS the Act also provides that all debentures issued under a by-law passed by a regional municipality for its own purposes are direct, joint and several obligations of the regional municipality and its lower-tier municipalities;

AND WHEREAS before authorizing the Projects and before authorizing any additional cost amounts and any additional debenture authorities in respect thereof, the Council of the Upper-tier Municipality had its Commissioner of Finance and Treasurer calculate an updated limit in respect of its most recent annual debt and financial obligation limit received from the Ministry of Municipal Affairs and Housing in accordance with the applicable regulation and, prior to the Council of the Upper-tier Municipality authorizing each Project, each such additional cost amount and each such additional debenture authority, the Commissioner of Finance and Treasurer determined that the estimated annual amount payable in respect of each Project, each such additional cost amount and each such additional debenture authority would not cause the Upper-tier Municipality to exceed the updated limit and that the approval of each Project, each such additional cost amount and each such additional debenture authority by the Ontario Municipal Board pursuant to such regulation was not required;

AND WHEREAS on May 30, 2007 the Upper-tier Municipality issued 3 year instalment debentures of the Upper-tier Municipality in the principal amount of \$20,725,000.00 and 10 year term debentures of the Upper-tier Municipality in the principal amount of \$58,660,000.00, in the aggregate principal amount of \$79,385,000.00 pursuant to debenture By-law No. D-0185-2007-046 for the purposes of the Upper-tier Municipality described therein;

AND WHEREAS the debentures issued on May 30, 2007 pursuant to debenture By-law No. D-0185-2007-046 form part of one series of debentures in the aggregate principal amount of \$101,500,000.00 (\$26,500,000.00 in the case of the instalment debentures and \$75,000,000.00 in the case of the term debentures) consolidated by debenture By-law No. D-0188-2007-049 and such by-laws provide that the Upper-tier Municipality reserves the right to issue additional debentures of the same maturities, interest rates and terms and conditions;

AND WHEREAS to provide long term financing for the Projects it is now deemed to be expedient to borrow money by the issue and sale of additional debentures as follows: 3 year instalment debentures of the Upper-tier Municipality in the principal amount of \$25,271,000.00 and 10 year term debentures of the Upper-tier Municipality in the principal amount of \$71,520,000.00, in the aggregate principal amount of \$96,791,000.00, payable at the times and bearing interest at the rates as hereinafter set forth, as agreed to by the Upper-tier Municipality on November 14, 2007;

NOW THEREFORE, the Council of The Regional Municipality of York hereby enacts as follows:

1. For the Projects, the borrowing upon the credit of the Upper-tier Municipality at large of:
 - (1) the principal amount of \$25,271,000.00 and the issue of additional 3 year instalment debentures of the same maturities, interest rates and terms and conditions as the instalment debentures issued pursuant to debenture By-law No. D-0185-2007-046 and forming part of one series of debentures consolidated by debenture By-law No. D-0188-2007-049, therefor (the “**Instalment Debentures**”); and
 - (2) the principal amount of \$71,520,000.00 and the issue of additional 10 year term debentures of the same maturity, interest rate and terms and conditions as the term debentures issued pursuant to debenture By-law No. D-0185-2007-046 and forming part of one series of debentures consolidated by debenture By-law No. D-0188-2007-049, therefor (the “**Term Debentures**”),

in the aggregate principal amount of \$96,791,000.00, in denominations of \$1,000.00 and any integral multiples thereof in the case of the Instalment Debentures and in minimum denominations of \$1,000.00 in the case of the Term Debentures, all as hereinafter set forth, are hereby authorized.

2. The Regional Chair and the Commissioner of Finance and Treasurer of the Upper-tier Municipality are hereby authorized to cause any number of Instalment Debentures in the principal amount of \$25,271,000.00 and any number of Term Debentures in the principal amount of \$71,520,000.00, in the aggregate principal amount of \$96,791,000.00, as described in section 1 above (the Instalment Debentures and the Term Debentures are hereinafter collectively referred to as the “**Debentures**”), payable in annual instalments of principal (May 30) with semi-

annual instalments of interest thereon (May 30 and November 30), in the case of the Instalment Debentures, and payable as to principal on the maturity date (May 30, 2017) with semi-annual instalments of interest thereon (May 30 and November 30), in the case of the Term Debentures. The Debentures are to be issued for such amounts of money as may be required for the Projects in global and definitive forms, not exceeding in total the said principal amount of \$96,791,000.00. The Debentures shall bear the Upper-tier Municipality's municipal seal and the signatures of the Regional Chair and of the Commissioner of Finance and Treasurer of the Upper-tier Municipality, all in accordance with the provisions of the Act. The municipal seal of the Upper-tier Municipality and the signatures referred to in this section may be printed, lithographed, engraved or otherwise mechanically reproduced. The Debentures are sufficiently signed if they bear the required signatures and each person signing has the authority to do so on the date he or she signs. The Instalment Debentures shall initially be issued in global fully registered form as part of one certificate, in the aggregate principal amount of \$26,500,000.00, substantially in the form of Schedule "B" attached hereto and forming part of this By-law (the "**Instalment Global Debenture**"). The Term Debentures shall initially be issued in global fully registered form as part of two certificates, each in the principal amount of \$37,500,000.00, in the aggregate principal amount of \$75,000,000.00, substantially in the form of Schedule "C" attached hereto and forming part of this By-law (the "**Term Global Debentures**"). The Instalment Global Debenture and the Term Global Debentures are hereinafter collectively referred to as the "**Global Debentures**". Each of the Global Debentures shall initially be issued in the name of CDS & CO. as nominee of CDS Clearing and Depository Services Inc. ("**CDS**"), and each shall provide for payment of principal and interest (other than in respect of the provision for the payment of principal and outstanding interest on the final maturity date upon presentation and surrender at the office of the Commissioner of Finance and Treasurer of the Upper-tier Municipality in the case of the Global Debentures or at any specified branch in Canada of the Upper-tier Municipality's bank in other cases) by cheque sent by mail to the registered address of the registered holder or, if the Upper-tier Municipality and the registered holder of the Global Debentures so consent, by electronic transfer of payment in respect of such principal and interest to the credit of such registered holder on such terms as to which the registered holder and the Upper-tier Municipality may agree.

3. The Debentures shall all be dated the 30th day of November, 2007, and as to both principal and interest shall be expressed and be payable in lawful money of Canada.

- (1) The Instalment Debentures shall mature within the term of years set out in Column (6) of Schedule "A" in respect of the Instalment Debentures and the respective amounts of interest or of principal and interest payable in each of the years during the currency of the Instalment Debentures shall be as set forth in Schedule "D" attached hereto and forming part of this By-law ("**Schedule "D"**"). The Instalment Debentures maturing (principal payable) in the year 2008 shall bear interest at the rate of 4.40% per annum, the Instalment Debentures maturing

(principal payable) in the year 2009 shall bear interest at the rate of 4.35% per annum and the Instalment Debentures maturing (principal payable) in the year 2010 shall bear interest at the rate of 4.40% per annum.

(2) The Term Debentures which comprise the remainder of the Debentures, shall bear interest in each year of their currency from November 30, 2007 at the rate of 4.60% per annum. In each year during the currency of the Term Debentures the amount of \$3,289,920.00 shall be payable for interest (\$1,644,960.00 on each of May 30 and November 30) and, after the principal of the Instalment Debentures issued under this By-law becomes payable on May 30, 2010, in each year of the Term Debentures, commencing on May 30, 2011, an amount of \$9,055,119.45 shall be deposited by the Commissioner of Finance and Treasurer of the Upper-tier Municipality, or an authorized official of the Upper-tier Municipality, into a retirement fund (the “**Retirement Fund**”), which amount, with interest compounded annually, will be sufficient to pay the principal of the Term Debentures at maturity (May 30, 2017) as required by the provisions of this By-law and the Act.

(3) Payments in respect of principal of and interest on the Debentures shall be made only on a day on which banking institutions in Toronto, Ontario are not authorized or obligated by law or executive order to be closed (a “**Business Day**”) and if any date for payment is not a Business Day, payment shall be made on the next following Business Day and no further interest shall be paid in respect of the delay in such payment.

4. Interest shall be payable to the date of maturity of the Debentures and on default shall be payable both before and after default and judgment. Any amounts payable by the Upper-tier Municipality as interest on overdue principal or interest in respect of the Debentures shall be paid out of current revenue. Whenever it is necessary to compute any amount of interest in respect of the Debentures for a period of less than one full year, other than with respect to regular semi-annual payments, such interest shall be calculated on the basis of the actual number of days in the period and a year of 365 days or 366 days, if applicable.
5. In limited circumstances (as set out in the letter of representations addressed to CDS referred to below and as set out in the Global Debentures) the Global Debentures shall be exchangeable for certificated Debentures in definitive fully registered form in authorized denominations upon surrender of the Global Debentures to the Commissioner of Finance and Treasurer of the Upper-tier Municipality provided that there is at least one definitive Debenture which matures in each of the remaining years of the currency of the Instalment Global Debenture. The definitive Debentures shall aggregate the same principal amount as the principal outstanding balance of the relevant Global Debentures as of the record date for such exchange in accordance with the provisions of the relevant Global Debentures, shall bear the same interest rates and maturity dates, shall bear all unmatured interest obligations and shall have the same benefits and be subject to the same terms and conditions as the relevant Global Debentures (except

insofar as they specifically relate to the relevant Global Debentures). In issuing definitive Debentures no change shall be made in the amount which would otherwise be payable in each year under the relevant Global Debentures. The definitive Debentures shall be in fully registered form, payable as to principal and outstanding interest in lawful money of Canada at maturity upon presentation and surrender thereof at any specified branch in Canada of the Upper-tier Municipality's bank designated in the definitive Debentures, otherwise, with provision for payment of principal and interest in the case of the Instalment Global Debenture and of interest in the case of the Term Global Debentures, by cheque sent by mail to the registered addresses of the registered holders or, if the Upper-tier Municipality and any registered holder of the definitive Debentures so consent, by electronic transfer of payment in respect of such principal and interest (as the case may be) to the credit of such registered holder on such terms as to which the registered holder and the Upper-tier Municipality may agree.

6. (1) In each year in which a payment of an instalment of interest or of principal and interest becomes due in respect of the Instalment Debentures, there shall be raised as part of the general upper-tier levy the amounts of interest or of principal and interest payable in each year as set out in Schedule "D" to the extent that the amounts have not been provided for by any other available source including other taxes or fees or charges imposed on persons or property by a by-law of any municipality.
- (2) In respect of the Term Debentures there shall be raised, as part of the general upper-tier levy, in each year of their currency the amount of \$3,289,920.00 which shall be payable for interest (\$1,644,960.00 on each of May 30 and November 30) and in each year commencing on May 30, 2011, the amount of \$9,055,119.45 for deposit into the Retirement Fund for the payment of the principal of the Term Debentures at maturity, and in each year, for the Projects, the said two amounts shall be raised as part of the general upper-tier levy, to the extent that such amounts have not been provided for by any other available source including other taxes or fees or charges imposed on persons or property by a by-law of any municipality.
- (3) The Upper-tier Municipality's lower-tier municipalities (individually a "**Lower-tier Municipality**", collectively the "**Lower-tier Municipalities**") shall pay to the Upper-tier Municipality, as part of the general upper-tier levy the amounts required to be paid to the Upper-tier Municipality by the Lower-tier Municipalities in respect of the Projects, in accordance with the manner in which the general upper-tier levy is required, from time to time, to be paid to the Upper-tier Municipality. Such amounts constitute debt of the Lower-tier Municipalities to the Upper-tier Municipality and such amounts shall, when combined with any amount payable by the Upper-tier Municipality in the year for repayment of the debt for which the Debentures are to be issued, be sufficient to meet the total amount of interest or of principal and interest payable and for the annual contribution to the Retirement Fund in the year by the Upper-tier Municipality in

respect of the Debentures, all in accordance with the provisions of this By-law and the Act.

(4) If any Lower-tier Municipality fails to make any payment or portion of it as provided in this By-law, such Lower-tier Municipality shall pay interest to the Upper-tier Municipality on the amount in default at the rate of 15% per annum, from the date the payment is due until it is made.

(5) There shall be raised, pursuant to this By-law, in each year of the currency of the Debentures, as part of the general upper-tier levy, the amounts required to be paid to the Upper-tier Municipality in any previous year by any one or more of the Lower-tier Municipalities to the extent that the amounts have not been paid to the Upper-tier Municipality in accordance with this By-law and the Act.

7. The Debentures may contain any provision for their registration thereof authorized by any statute relating to municipal debentures in force at the time of the issue thereof.
8. The Upper-tier Municipality shall maintain a registry in respect of the Debentures in which shall be recorded the names and the addresses of the registered holders and particulars of the Debentures held by them respectively and in which particulars of the cancellations, exchanges, substitutions and transfers of Debentures may be recorded and the Upper-tier Municipality is authorized to use electronic, magnetic or other media for records of or related to the Debentures or for copies of them.
9. The Upper-tier Municipality shall not be bound to see to the execution of any trust affecting the ownership of any Debenture or be affected by notice of any equity that may be subsisting in respect thereof. The Upper-tier Municipality shall deem and treat registered holders of the Debentures, including the Global Debentures, as the absolute owners thereof for all purposes whatsoever notwithstanding any notice to the contrary and all payments to or to the order of registered holders shall be valid and effectual to discharge the liability of the Upper-tier Municipality on the Debentures to the extent of the amount or amounts so paid. Where a Debenture is registered in more than one name, the principal of and interest from time to time payable on such Debenture shall be paid to or to the order of all the joint registered holders thereof, failing written instructions to the contrary from all such joint registered holders, and such payment shall constitute a valid discharge to the Upper-tier Municipality. In the case of the death of one or more joint registered holders, despite the foregoing provisions of this section, the principal of and interest on any Debentures registered in their names may be paid to the survivor or survivors of such holders and such payment shall constitute a valid discharge to the Upper-tier Municipality.
10. The Debentures are transferable or exchangeable at the office of the Commissioner of Finance and Treasurer of the Upper-tier Municipality upon presentation for such purpose accompanied by an instrument of transfer or

exchange in a form approved by the Upper-tier Municipality and which form is in accordance with the prevailing Canadian transfer legislation and practices, executed by the registered holder thereof or such holder's duly authorized attorney or legal personal representative, whereupon and upon registration of such transfer or exchange and cancellation of the Debenture or Debentures presented, the Regional Chair and the Commissioner of Finance and Treasurer shall issue and deliver a new Debenture or Debentures of an equal aggregate principal amount in any authorized denomination or denominations as directed by the transferee, in the case of a transfer or as directed by the registered holder in the case of an exchange.

11. The Regional Chair and the Commissioner of Finance and Treasurer shall issue and deliver new Debentures in exchange or substitution for Debentures outstanding on the registry with the same maturity dates and of like form which have become lost, stolen, mutilated, defaced or destroyed, provided that the applicant therefor shall have: (a) paid such costs as may have been incurred in connection therewith; (b) (in the case of a lost, stolen or destroyed Debenture) furnished the Upper-tier Municipality with such evidence (including evidence as to the certificate number of the Debenture in question) and indemnity in respect thereof satisfactory to the Upper-tier Municipality in its discretion; and (c) surrendered to the Upper-tier Municipality any mutilated or defaced Debenture in respect of which new Debentures are to be issued in substitution.
12. The Debentures issued upon any registration of transfer or exchange or in substitution for any Debentures or part thereof shall carry all the rights to interest if any, accrued and unpaid which were carried by such Debentures or part thereof and shall be so dated and shall bear the same maturity dates and, subject to the provisions of this By-law, shall be subject to the same terms and conditions as the Debentures in respect of which the transfer, exchange or substitution is effected.
13. The cost of all transfers and exchanges, including the printing of authorized denominations of the new Debentures, shall be borne by the Upper-tier Municipality. When any of the Debentures are surrendered for transfer or exchange the Commissioner of Finance and Treasurer of the Upper-tier Municipality shall: (a) in the case of an exchange, cancel and destroy the Debentures surrendered for exchange; (b) in the case of an exchange, certify the cancellation and destruction in the registry; and (c) enter in the registry particulars of the new Debenture or Debentures issued in exchange.
14. Reasonable fees for the substitution of a new Debenture or new Debentures for any of the Debentures that are lost, stolen, mutilated, defaced or destroyed and for the replacement of lost, stolen, mutilated, defaced or destroyed interest cheques or principal and interest cheques may be imposed by the Upper-tier Municipality. Where new Debentures are issued in substitution in these circumstances the Upper-tier Municipality shall: (a) treat as cancelled and destroyed the Debentures in respect of which new Debentures will be issued in substitution; (b) certify the deemed cancellation and destruction in the registry; (c) enter in the registry

particulars of the new Debentures issued in substitution; and (d) make a notation of any indemnities provided.

15. Except as otherwise expressly provided herein, any notice required to be given to a registered holder of one or more of the Debentures will be sufficiently given if a copy of such notice is mailed or otherwise delivered to the registered address of such registered holder.
16. (1) The execution of a purchase letter in respect of the Debentures, dated as at November 14, 2007, by the Director of Policy, Risk and Treasury is hereby ratified, confirmed and approved, the Regional Chair and the Commissioner of Finance and Treasurer are hereby authorized to cause the Debentures to be issued, the Commissioner of Finance and Treasurer is hereby authorized to enter into a letter of representations with CDS, the Commissioner of Finance and Treasurer and the Regional Clerk are hereby individually authorized to generally do all things and to execute all other documents and papers in the name of the Upper-tier Municipality in order to carry out the sale of the Debentures and the Commissioner of Finance and Treasurer is authorized to affix the Upper-tier Municipality's municipal seal to any of such documents and papers.

(2) The money received by the Upper-tier Municipality from the sale of the Debentures, including any premium, and any earnings derived from the investment of that money, shall be apportioned and applied to the Projects, and to no other purpose except as permitted by the Act.
17. The Upper-tier Municipality reserves the right to issue additional debentures of the same maturities, interest rates and terms and conditions.
18. Subject to the Upper-tier Municipality's investment policies and goals and the applicable legislation, the Upper-tier Municipality may, if not in default under the Debentures, at any time purchase any of the Debentures in the open market or by tender or by private contract at any price and on such terms and conditions (including, without limitation, the manner by which any tender offer may be communicated or accepted and the persons to whom it may be addressed) as the Upper-tier Municipality may in its discretion determine.

LEGAL OPINION

We have examined the Debenture By-law of the Upper-tier Municipality authorizing the issue of instalment debentures in the principal amount of \$26,500,000 (the “**Instalment Debentures**”) and the term debentures in the principal amount of \$75,000,000 (the “**Term Debentures**”), in the aggregate principal amount of \$101,500,000 dated November 30, 2007 (the Instalment Debentures and the Term Debentures are hereinafter collectively referred to as the “**Debentures**”). The Instalment Debentures shall mature in three (3) instalments of principal of varying amounts on the 30th day of May in each of the years 2008 to 2010, both inclusive. The Term Debentures shall mature on the 30th of May, 2017.

The Debenture By-law has been properly passed and is within the legal powers of the Upper-tier Municipality. The global debenture issued under the Debenture By-law in the within form (the “**Global Debenture**”) is the direct, unsecured, unsubordinated, joint and several obligation of the Upper-tier Municipality and of its lower-tier municipalities (the “**Lower-tier Municipalities**”). The Global Debenture is enforceable against the Upper-tier Municipality and the Lower-tier Municipalities subject to the special jurisdiction and powers of the Ontario Municipal Board over defaulting municipalities under the *Municipal Affairs Act*, as amended. This opinion is subject to and incorporates all the assumptions, qualifications and limitations set out in our opinion letter delivered on the date of the Global Debenture.

CONDITIONS OF GLOBAL DEBENTURE

Form, Denomination, Ranking and Beneficial Interests in Global Debenture

1. The debentures issued pursuant to the Debenture By-law (individually a “**Debenture**”, collectively the “**Debentures**”) are issuable as fully registered Debentures without coupons in denominations of \$1,000 and any integral multiples thereof.
2. The Debentures are direct, unsecured, unsubordinated, joint and several obligations of the Upper-tier Municipality and of the Lower-tier Municipalities. The Debentures rank concurrently and equally in respect of payment of principal and interest with all other debentures of the Upper-tier Municipality except for the availability of money in a sinking or retirement fund for a particular issue of debentures.
3. This Debenture is a Global Debenture registered in the name of the nominee of CDS and held by CDS. Beneficial interests in this Global Debenture are represented through book entry accounts, to be established and maintained by CDS, for financial institutions acting on behalf of beneficial owners as direct and indirect participants in CDS’ book entry only system.
4. Except in the limited circumstances described herein, owners of beneficial interests in this Global Debenture will not be entitled to have Debentures registered in their names, will not receive or be entitled to receive physical delivery of Debentures and will not be considered registered holders of Debentures under the Conditions. Title

9. The Upper-tier Municipality shall not be bound to see to the execution of any trust affecting the ownership of any Debenture or be affected by notice of any equity that may be subsisting in respect thereof. The Upper-tier Municipality shall deem and treat registered holders of Debentures, including this Global Debenture, as the absolute owners thereof for all purposes whatsoever notwithstanding any notice to the contrary and all payments to or to the order of registered holders shall be valid and effectual to discharge the liability of the Upper-tier Municipality on the Debentures to the extent of the amount or amounts so paid.

Payments of Principal and Interest

11. The Upper-tier Municipality shall make all payments in respect of annual principal and semi-annual interest on the Debentures on each Payment Date commencing on May 30, 2008 (other than in respect of the payment of principal and outstanding interest on the final maturity date which shall be paid upon presentation and surrender of this Global Debenture at the office of the Commissioner of Finance and Treasurer of the Upper-tier Municipality or at any specified branch in Canada of the Upper-tier Municipality's bank in other cases), by forwarding by mail, a cheque dated the due date for payment to the registered address of each registered holder of Debentures sufficiently in advance of the relevant due date that delivery of such cheques to the registered address of each registered holder on or before the due date is reasonably assured. LEGAL OPINION

We have examined the Debenture By-law of the Upper-tier Municipality authorizing the issue of instalment debentures in the principal amount of \$75,000,000 (the “**Instalment Debentures**”) and the term debentures in the principal amount of \$26,500,000 (the “**Term Debentures**”), in the aggregate principal amount of \$101,500,000 dated November 30, 2007 (the Instalment Debentures and the Term Debentures are hereinafter collectively referred to as the “**Debentures**”). The Instalment Debentures shall mature in three (3) instalments of principal of varying amounts on the 30th day of May in each of the years 2008 to 2010, both inclusive. The Term Debentures shall mature on the 30th of May, 2017.

The Debenture By-law has been properly passed and is within the legal powers of the Upper-tier Municipality. The global debentures issued under the Debenture By-law in the within form (the “**Global Debentures**”) are the direct, general, unsubordinated, joint and several obligations of the Upper-tier Municipality and of its lower-tier municipalities (the “**Lower-tier Municipalities**”). The Global Debentures are enforceable against the Upper-tier Municipality and the Lower-tier Municipalities subject to the special jurisdiction and powers of the Ontario Municipal Board over defaulting municipalities under the *Municipal Affairs Act*, as amended. This opinion is subject to and incorporates all the assumptions, qualifications and limitations set out in our opinion letter delivered on the date of the Global Debentures.

CONDITIONS OF GLOBAL DEBENTURE

Form, Denomination, Ranking and Beneficial Interests in Global Debenture

1. The Term Debentures are issuable as fully registered Term Debentures without coupons in minimum denominations of \$1,000.
2. The Term Debentures are direct, general, unsubordinated, joint and several obligations of the Upper-tier Municipality and of the Lower-tier Municipalities. The Term Debentures rank concurrently and equally in respect of payment of principal and interest with all other debentures of the Upper-tier Municipality except for the availability of money in a sinking or retirement fund for a particular issue of debentures.
3. This Debenture is a Global Debenture registered in the name of the nominee of CDS and held by CDS. Beneficial interests in this Global Debenture are represented through book entry accounts, to be established and maintained by CDS, for financial institutions acting on behalf of beneficial owners as direct and indirect participants in CDS' book entry only system.
4. Except in the limited circumstances described herein, owners of beneficial interests in this Global Debenture will not be entitled to have Term Debentures registered in their names, will not receive or be entitled to receive physical delivery of Term Debentures and will not be considered registered holders of Term Debentures under the Conditions. The Upper-tier Municipality does not have any responsibility or liability for maintaining, supervising or reviewing any records of CDS relating to beneficial interests in this Global Debenture or for any aspect of the records of CDS relating to payments made by CDS on account of such beneficial interests.

Certificated Term Debentures

5. This Global Debenture is exchangeable, in whole but not in part, for certificated Term Debentures in definitive form registered in the name of a person other than CDS or its nominee only if (i) CDS notifies the Upper-tier Municipality that it is unable to continue as depository in connection with this Global Debenture or ceases to be a recognized clearing agency under the *Securities Act*, as amended, or other applicable Canadian securities legislation and a successor depository is not appointed by the Upper-tier Municipality or (ii) the Upper-tier Municipality in its sole discretion elects to issue certificated Term Debentures in definitive form in exchange for this Global Debenture.
6. Term Debentures issued in exchange for this Global Debenture shall be issued as certificated Term Debentures in definitive form in authorized denominations, shall have the same benefits and be subject to the same terms and conditions as this Global Debenture (except insofar as they specifically relate to this Global Debenture as such), shall be registered in such names and in such denominations as CDS shall direct and shall be delivered as directed by the persons in whose names such definitive Term Debentures are to be registered.
7. Upon the exchange of certificated Term Debentures in definitive form for this Global Debenture, the Upper-tier Municipality shall receive and cancel this Global Debenture, shall reduce the holdings of CDS & CO. on the registry to nil and shall issue or cause to be issued in exchange for this Global Debenture certificated Term Debentures in definitive form in an aggregate principal amount equal to and in exchange for the CDS participants' proportionate interests in this Global Debenture as of the record date for such exchange, as directed by CDS. On or after any such exchange, but only to the extent reasonably practicable in the circumstances, the Upper-tier Municipality shall make all payments in respect of such

certificated Term Debentures in definitive form to the registered holders thereof, notwithstanding such exchange occurred after the record date for any payment and prior to such payment date.

Registration

8. The Upper-tier Municipality will keep at its designated office in the Regional Municipality of York a registry in which shall be entered the names and addresses of the registered holders of Term Debentures and particulars of the Term Debentures held by them respectively and in which transfers, exchanges and substitutions of Term Debentures may be registered.

Title

9. The Upper-tier Municipality shall not be bound to see to the execution of any trust affecting the ownership of any Debenture or be affected by notice of any equity that may be subsisting in respect thereof. The Upper-tier Municipality shall deem and treat registered holders of Term Debentures, including this Global Debenture, as the absolute owners thereof for all purposes whatsoever notwithstanding any notice to the contrary and all payments to or to the order of registered holders shall be valid and effectual to discharge the liability of the Upper-tier Municipality on the Term Debentures to the extent of the amount or amounts so paid.

Payments of Principal and Interest

10. There shall be raised for interest on the Term Debentures in each year of their currency the amount of \$3,450,000.00 for the payment of interest (\$1,725,000.00 on each of May 30 and November 30). After the principal of the Instalment Debentures issued under the Debenture By-law becomes payable, in each year during the currency of the Term Debentures, commencing on May 30, 2011, an amount of \$9,495,720.90 shall be deposited by the Upper-tier Municipality into a retirement fund for the payment of principal of the Term Debentures at maturity (the “**Retirement Fund**”), all in accordance with the provisions of the Debenture By-law and the *Municipal Act, 2001*, as amended.
11. The record date for purposes of payment of principal and of interest on the Term Debentures is as of 5:00 p.m. on the thirtieth calendar day preceding any Payment Date, including the maturity date. Principal of and interest on the Term Debentures are payable by the Upper-tier Municipality to the persons registered as holders in the registry on the relevant record date. The Upper-tier Municipality shall not be required to register any transfer, exchange or substitution of Term Debentures during the period from any record date to the corresponding Payment Date.
12. The Upper-tier Municipality shall make all payments in respect of semi-annual interest on the Term Debentures on each Payment Date commencing on May 30, 2008 (other than in respect of the payment of principal and outstanding interest on the maturity date which shall be paid upon presentation and surrender of this Global Debenture at the office of the Commissioner of Finance and Treasurer of the Upper-tier Municipality or at any specified branch in Canada of the Upper-tier Municipality’s bank in other cases), by forwarding by mail, a cheque dated the due date for payment to the registered address of each registered holder of Term Debentures sufficiently in advance of the relevant due date that delivery of such cheques to the registered address of each registered holder on or before the due date is reasonably assured. All cheques mailed or otherwise delivered in accordance with this section shall be dated the due

date for payment of the interest in respect of which they are issued. Despite the foregoing, the Upper-tier Municipality may make payments in respect of interest on any Term Debenture (other than in respect of the payment of principal and outstanding interest payable on the maturity date upon presentation and surrender at the office of the Commissioner of Finance and Treasurer of the Upper-tier Municipality or at any specified branch in Canada of the Upper-tier Municipality's bank, as applicable) to the credit of the registered holder of that Debenture, by electronic transfer of payment in respect of such interest to the credit of the registered holder on such terms as to which the registered holder and the Upper-tier Municipality may agree.

13. Whenever it is necessary to compute any amount of interest in respect of the Term Debentures for a period of less than one full year, other than with respect to regular semi-annual interest payments, such interest shall be calculated on the basis of the actual number of days in the period and a year of 365 days or 366 days, if applicable.
14. Payments in respect of principal of and interest on the Term Debentures shall be made only on a day on which banking institutions in Toronto, Ontario, are not authorized or obligated by law or executive order to be closed (a "**Business Day**"), and if any date for payment is not a Business Day, payment shall be made on the next following Business Day and no further interest shall be paid in respect of the delay in such payment.
15. Where a Term Debenture is registered in more than one name, the principal of and interest from time to time payable on such Term Debenture shall be paid to or to the order of all the joint registered holders thereof, failing written instructions to the contrary from all such joint registered holders, and such payment shall constitute a valid discharge to the Upper-tier Municipality.
16. In the case of the death of one or more joint registered holders, despite sections 9 and 15 of the Conditions, the principal of and interest on any Term Debentures registered in their names may be paid to the survivor or survivors of such holders and such payment shall constitute a valid discharge to the Upper-tier Municipality.

Transfers, Exchanges and Substitutions

17. Term Debentures are transferable or exchangeable at the office of the Commissioner of Finance and Treasurer of the Upper-tier Municipality upon presentation for such purpose accompanied by an instrument of transfer or exchange in a form approved by the Upper-tier Municipality and which form is in accordance with the prevailing Canadian transfer legislation and practices, executed by the registered holder thereof or such holder's duly authorized attorney or legal personal representative, whereupon and upon registration of such transfer or exchange and cancellation of the Term Debenture or Term Debentures presented, a new Term Debenture or Term Debentures of an equal aggregate principal amount in any authorized denomination or denominations will be delivered as directed by the transferee, in the case of a transfer or as directed by the registered holder in the case of an exchange.
18. The Upper-tier Municipality shall issue and deliver Term Debentures in exchange for or in substitution for Term Debentures outstanding on the registry with the same maturity date and of like form which have become lost, stolen, mutilated, defaced or destroyed provided that the applicant therefor shall have (i) paid such costs as may have been incurred in connection therewith; (ii) (in the case of a lost, stolen or destroyed Term Debenture) furnished the Upper-tier Municipality with such evidence (including evidence as to the certificate number of the Term Debenture in question) and indemnity in respect thereof

satisfactory to the Upper-tier Municipality in its discretion; and (iii) surrendered to the Upper-tier Municipality any mutilated or defaced Term Debenture in respect of which new Term Debentures are to be issued in substitution.

19. Each Term Debenture executed and delivered upon any registration of transfer or exchange for or in substitution for any Term Debenture or part thereof shall carry all the rights to interest, if any, accrued and unpaid which were carried by such Term Debenture or part thereof and shall be so dated.
20. The Upper-tier Municipality shall not impose any fees in respect of the Term Debentures, in the normal course of business, other than reasonable fees for the issue of new Term Debentures or for the issue of new cheques in substitution for lost, stolen, mutilated, defaced or destroyed Term Debentures or interest cheques.

Purchases

21. Subject to the investment policies and goals of the Upper-tier Municipality and the applicable legislation, the Upper-tier Municipality may, if not in default under the Term Debentures, at any time purchase Term Debentures in the open market or by tender or by private contract at any price and on such terms and conditions (including without limitation, the manner by which any tender offer may be communicated or accepted and the persons to whom it may be addressed) as the Upper-tier Municipality may in its discretion determine.

Additional Debentures

22. The Upper-tier Municipality has reserved the right to issue additional term debentures of the same maturity, interest rate and terms and conditions.

Notices

23. Except as otherwise expressly provided herein, any notice required to be given to a registered holder of one or more of the Term Debentures will be sufficiently given if a copy of such notice is mailed or otherwise delivered to the registered address of such registered holder. If the Upper-tier Municipality or any registered holder is required to give any notice in connection with the Term Debentures on or before any day and that day is not a Business Day then such notice may be given on the next following Business Day.

Time

24. Unless otherwise expressly provided herein, any reference herein to a time shall be considered to be a reference to Toronto time.

Governing Law

25. The Term Debentures are governed by and shall be construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable in Ontario.
