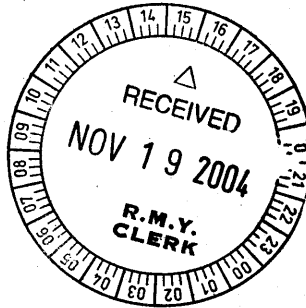

**Re: Region of Durham Residual Waste Disposal Planning Study
Development of Environmental Assessment
Terms of Reference - Notice of Project Initiation**

The Region of Durham Works Department, Waste Management Services Division, would like to notify you and your organization that the Region has initiated a Planning Study to conduct a full Ontario Environmental Assessment (EA) to evaluate alternative technologies (physical, biological and/or thermal) for the processing and disposal of residential residual waste to maximize the recovery of recyclables and energy, while minimizing the amount of material requiring landfill disposal.¹

This Planning Study will be subject to the requirements of Ontario's Environmental Assessment Act relating to municipal waste disposal undertakings. The first phase of the Planning Study is the development of **Environmental Assessment Terms of Reference** that will be used to guide the EA study.

The Table below shows study timelines for the Terms of Reference development, completion of EA activities, and eventual facility design and construction:

• Development of EA Terms of Reference	Dec 2004 – April 2005
• Submission of Proposed Terms of Reference to Minister of Environment	May – June 2005
• Review and Approval of Terms of Reference by Minister of Environment	Fall 2005
• Initiation of the full EA Study	Late 2005
• Completion of EA study	2007 – 2008

¹ Note that "residual residential waste" does not include recyclables collected in the Region's Blue Box Program, nor compostables collected in the Region's Kitchen Food Waste or Yard Waste Program, nor any Household Hazardous Waste delivered to the Region of Durham's Waste Management Facilities by residents.



• Review and Approval of EA Study	2008
• Detailed Design and Site Specific Approvals	2008 - 2010
• Facility Construction	2010 – 2012

Development of the Terms of Reference will include several opportunities for Agency and Public input, including Public Consultation Events, to be held throughout the development process. The Public and Agencies will also be provided an opportunity to review the draft Terms of Reference document and submit comments prior to its submission to the Ontario Minister of the Environment. Based on our current schedule, a draft Terms of Reference will be available for review in February 2004 prior to our planned submission of the proposed Terms of Reference to the Ontario Minister of Environment in May/June 2005.

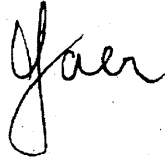
These Public Information Sessions are intended to introduce Residents and Agencies to the residual waste disposal study, the Ontario Environmental Assessment Act.
