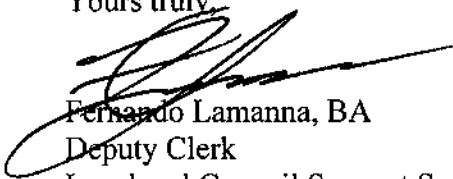
For your information and records, at its regular meeting held December 5, 2011, the Municipal Council of the Town of East Gwillimbury adopted the following resolution:

Subject: Traffic light at Green Lane and the GO Station

Dear Sirs,

Would it be possible for the Town to review the above intersection and the timing of the traffic lights?

I travel westbound on Green Lane and have to make a left turn into the GO station every morning. Eastbound traffic can be very heavy, and the traffic light is not set to cycle to red for traffic on Green Lane, unless someone leaves the GO station and sits in the left turn lane. If nobody comes out of the GO parking lot, the lights will not change, which makes it difficult to make the left turn.

It would be greatly appreciated if the Town could look into this, and perhaps during the morning rush hour set the lights to cycle independent of traffic turning west from the GO station.
