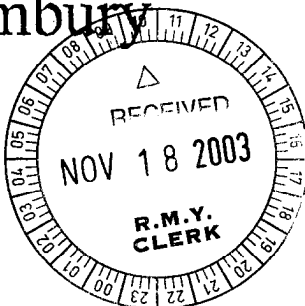

WHEREAS the 2nd Concession Road in the Town of East Gwillimbury serves traffic from a Regional perspective, namely the communities of Holland Landing, Sharon, Queensville and Keswick in the Towns of East Gwillimbury and Georgina by providing a direct link to the Town of Newmarket;

AND WHEREAS the 2nd Concession Road provides an indirect western link to Highway Number 9 and a direct link to Highway #404 through the Green Lane corridor;

AND WHEREAS the 2nd Concession Road from the Mount Albert Road to Green Lane is included as a future Regional Road in the Official Plan of the Region of York;

AND WHEREAS the balance of the 2nd Concession Road will continue to function as a regional road particularly in light of the approved developments of Holland Landing, Sharon, Queensville and Keswick;

AND WHEREAS the current approved plan for the Bradford By-Pass includes the crossing of the highway by the 2nd Concession Road so that the road will be continuous from Holborn Road to Green Lane.

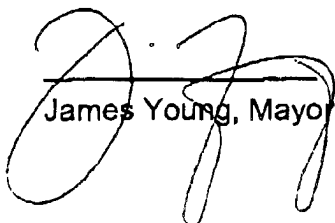
Therefore be it Resolved that the Region of York be requested to assume the 2nd Concession Road from Holborn Road to Green Lane;
