A by-law to amend by-law L-0134-2006-025, being a by-law to set and levy the rates of taxation for Regional general purposes for the year 2006

WHEREAS on March 23, 2006, Regional Council enacted By-law No. L-0134-2006-025, being a by-law to set and levy the rates of taxation for Regional general purposes for the year 2006;

AND WHEREAS in Schedule "A" of By-law No. L-0134-2006-025 the figures for quarterly payments in columns 6, 7, 8 and 9 for the Town of Whitchurch-Stouffville are incorrect.

NOW THEREFORE the Council of The Regional Municipality of York hereby enacts as follows:

1. By-law No. L-0134-2006-025 is hereby amended by replacing Schedule "A" with the attached revised Schedule "A".
2. This by-law shall be effective as of March 23, 2006.
