

THE REGIONAL MUNICIPALITY OF YORK

BY-LAW NO. L-0136-2007-018

To levy against the lower-tier municipalities on an interim basis the sums of monies required during the year 2007 for the purposes of The Regional Municipality of York

WHEREAS subsection 316(1) of the *Municipal Act, 2001* (the "Act") provides that the council of an upper-tier municipality may, before the adoption of the estimates for a year, by by-law requisition a sum from each lower-tier municipality calculated in accordance with the Act;

AND WHEREAS it is deemed expedient to levy against each lower-tier municipality set out in Column 1 of the schedule set out in section 1 of this By-law, the specified sum set out opposite such lower-tier municipality in Column 2 of the schedule;

AND WHEREAS the sum set out in Column 2 of the schedule opposite each lower-tier municipality set out in Column 1 of the schedule does not exceed fifty percent (50%) of the levy made by the Regional Council against such lower-tier municipality in the year 2006;

NOW THEREFORE the Council of The Regional Municipality of York enacts as follows:

1. Each specific sum set out in Column 2 of the schedule set out in this section is hereby levied for the year 2007 for the purposes of the Regional Corporation against the lower-tier municipality set out opposite such sum in Column 1 of the schedule.

The following is the schedule above referred to:

2. The Treasurer of each municipality set out in Column 1 of the schedule set out in section 1 shall pay to the Treasurer of the Regional Corporation the specific sum levied against such lower-tier municipality by section 1 in the amounts and at the times following:

- (a) fifty percent (50%) of such sum on or before the 27th day of April, 2007;
and
- (b) the balance of such sum on or before the 29th day of June, 2007.

3. The amount of the levy against each lower-tier municipality under section 1 shall be deducted from any future levy made against such lower-tier municipality for the purposes of the Regional Corporation for 2007.
