

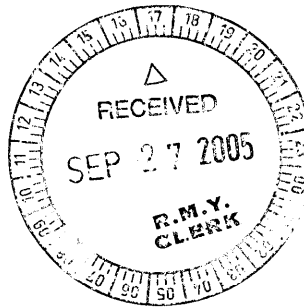

Dear Mayor Miller:

Thank you for inviting me to join you at the Municipal Leaders' Summit on Social Services Funding. I am planning to attend the meeting on September 16th.

I have reviewed the preliminary draft of the communiqué and while I am content with the general wording and message, I ask that a specific comment on the elimination of GTA Pooling be included in it. GTA Pooling is a direct result of the Provincial Government's requirement that municipalities in the GTA use property taxes to fund social housing and social assistance programs. I recommend that the communiqué calls for:

- The immediate freezing of contributions to GTA Pooling at current levels
- The phasing out of Pooling in the GTA over a two year period that coincides with the two year period that we are asking the Province to assume the costs of ODSP and ODB.

I look forward to the meeting on September 16th.
