

THE REGIONAL MUNICIPALITY OF YORK

BY-LAW NO. R-1401-2004-072

To provide for restricted loads on
certain Regional Roads

WHEREAS Section 122(7) of the *Highway Traffic Act* provides that a municipality having jurisdiction over a highway may by by-law designate the date on which a reduced load period shall start or end and the highway or portion thereof to which the designation applies;

Now therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The gross weight of commercial vehicles shall be restricted to 5 tonnes per axle for the period commencing November 22, 2004 and ending November 21, 2007 inclusive with respect to that portion of the highway designated or named in Column 1 lying between the limits set out opposite such highway in Column 2 of the following table:

14 th Avenue (Y.R. 71)	9 th Line (Y.R. 69) and York/Durham Line (Y.R. 30), in the town of Markham
16 th Avenue (Y.R. 73)	Markham by-pass and York/Durham Line (Y.R. 30), in the Town of Markham
York/Durham Line (Y.R. 30)	Steeles Avenue and 407 ETR, and between Highway 7 (Y.R. 7) and Durham Road 5 and between Main Street, Stouffville and 600 metres south of Bloomington Road (Y.R. 40), in the Towns of Markham and Whitchurch-Stouffville
St. John's Sideroad (Y.R. 26)	Bayview Avenue (Y.R. 34) and Woodbine Avenue (Y.R. 8), in the Towns of Whitchurch-Stouffville and Aurora
Warden Avenue (Y.R. 65)	Bloomington Road (Y.R. 40) and Davis Drive (Y.R. 31), in the Town of Whitchurch-Stouffville
Kennedy Road (Y.R. 3)	Aurora Road (Y.R. 15) and Davis Drive (Y.R. 31), and between Mount Albert Road (Y.R. 13) and Boag Road, in the Towns of East Gwillimbury and Whitchurch-Stouffville
Doane Road (Y.R. 45)	Old Yonge Street (Y.R. 51) and Woodbine Avenue (Y.R. 8), in the Town of East Gwillimbury
McCowan Road (Y.R. 67)	Davis Drive (Y.R. 32) and 1.5 kms south of Mount Albert Road (Y.R. 13) and between Mount Albert Road (Y.R. 13) and Ravenshoe Road (Y.R. 32), in the Town of East

Ravenshoe Road (Y.R. 32)	Prout Road and Weir's Sideroad (Y.R. 81), and between Victoria Road (Y.R. 82) and Durham Road 23, in the Town of Georgina
Old Homestead Road (Y.R. 79)	Warden Avenue (Y.R. 65) and Highway 48, in the Town of Georgina
