BY-LAW NO. R-1413-2005-025

To authorize the Commissioner of Transportation and Works
to temporarily close certain Regional roads

WHEREAS certain Regional roads shall be closed temporarily to through traffic
to accommodate construction projects;

AND WHEREAS section 42 of the *Municipal Act, 2001* provides that a council
may delegate to an employee the power to close a highway temporarily for any purpose
specified in the by-law;

NOW THEREFORE, the Council of The Regional Municipality of York
HEREBY ENACTS as follows:

1. The Commissioner of Transportation and Works is hereby authorized to exercise
all of the powers of Council with respect to the temporary closing of the
following Regional roads for such time as is required during construction
between the dates indicated:
 - (a) St. John's Sideroad (Y.R. 26) from Bayview Avenue (Y.R. 34) to Leslie
Street (Y.R. 12) in the Town of Aurora for a duration of approximately
three months between May and August 2005;
 - (b) Gamble Road (Y.R. 29) from Bathurst Street (Y.R. 38) to Yonge Street
(Y.R. 1) in the Town of Richmond Hill for a duration of approximately
four weeks between July and August 2005;

- (c) Lloydtown-Aurora Road (Y.R. 16) from Dufferin Street (Y.R. 53) to Keele Street (Y.R. 6) in the Township of King for a duration of approximately three days being a Friday, Saturday and Sunday during June and July 2005;
- (d) Warden Avenue (Y.R. 65) from Herald Road to Vivian Road (Y.R. 74) in the Towns of East Gwillimbury and Whitchurch-Stouffville for a duration of approximately two weeks on the north side and four weeks on the south side during July and August 2005;
- (e) Warden Avenue (Y.R. 65) from Doane Road (Y.R. 45) to Herald Road in the Town of East Gwillimbury for a duration of approximately four weeks during September and October 2005;
- (f) 16th Avenue (Y.R. 73) from Markham Bypass (Y.R. 48) to Reesor Road (Y.R. 70) in the Town of Markham for a duration of approximately four weeks during August and November 2005;
- (g) Major Mackenzie Drive (Y.R. 25) from Weston Road (Y.R. 56) to Vellore Woods Boulevard in the City of Vaughan for a duration of approximately three days being a Friday, Saturday and Sunday in May 2005; and
- (h) 16th Avenue (Y.R. 73) from Kennedy Road (Y.R. 3) to McCowan Road (Y.R. 67) in the Town of Markham for a duration of approximately one week in June 2005.
