BY-LAW NO. R-1416-2005-029

To acquire certain lands for or in connection with the
widening and reconstructing of Teston Road (YR 49)
in the City of Vaughan

WHEREAS the Council of The Regional Municipality of York on February 19, 2004, by its adoption of Clause 10 of Report 2 of the Transportation and Works Committee, on April 22, 2004, by its adoption of Clause 14 of Report 4 of the Transportation and Works Committee and on September 23, 2004, by its adoption of Clause 19 of Report 8 of the Transportation and Works Committee, approved of the expropriation of the lands and interest in lands therein referred to for or in connection with widening and reconstructing Teston Road (YR 49) from Weston Road (YR 56) to Keele Street (YR 6) and from Dufferin Street (YR 53) to Bathurst Street (YR 38), in the City of Vaughan, provided that there were no requests for a hearing of necessity; and

WHEREAS Notice of Application for Approval to Expropriate Land has been served upon the registered owners of the lands and interest in lands and has been published pursuant to the provisions of the *Expropriations Act*, R.S.O. 1990, Chapter E.26; and

WHEREAS no notification of a desire for a hearing has been received and the time for giving such notification has expired.

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The expropriation of the lands and interest in lands referred to in section 2 is hereby approved and the Regional Chair and Regional Clerk are authorized to execute any required documents in accordance with the *Expropriations Act*.

2. The lands described and designated as follows:

are hereby expropriated and taken for or in connection with widening and reconstructing Teston Road (YR 49) from:

(a) Weston Road (YR 56) to Keele Street (YR 6); and

(b) Dufferin Street (YR 53) to Bathurst Street (YR 38).

3. (1) The Regional Chair and Regional Clerk are hereby authorized and directed to sign a plan or plans showing the lands expropriated.

(2) When so signed, the Regional Commissioner of Corporate Services is directed to cause the said plan or plans to be registered in the proper Land Registry Office and to pay all expenses incidental to the registration.

4. Plan Nos. 65R-26573, 65R-26755, 65R-27127, 65R-27706, 65R-27707, 65R-27708 and 65R-27709, hereto attached, shall form part of this by-law.
