BY-LAW NO. RD-0506-2003-071

To dedicate certain lands for
the purposes of public highways

WHEREAS the hereinafter described lands are vested in The Regional Municipality of York for highway purposes;

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The acquisition of the lands described in Schedules “A”, “B”, “C”, “D”, “E”, “F”, “G”, “H”, “I”, “J”, “K”, “L” and “M”, hereto attached, is hereby authorized, ratified and confirmed.
2. The lands described in Schedule “A”, hereto attached, are hereby dedicated as a public highway and declared to form part of Bathurst Street (YR 38).
3. The lands described in Schedule “B”, hereto attached, are hereby dedicated as a public highway and declared to form part of Rutherford Road (YR 73).
4. The lands described in Schedule “C”, hereto attached, are hereby dedicated as a public highway and declared to form part of Markham Road (YR 68).
5. The lands described in Schedule “D”, hereto attached, are hereby dedicated as a public highway and declared to form part of Warden Avenue (YR 65).

6. The lands described in Schedule “E”, hereto attached, are hereby dedicated as a public highway and declared to form part of Jane Street (YR 55).
7. The lands described in Schedule “F”, hereto attached, are hereby dedicated as a public highway and declared to form part of Nashville Road (YR 49).
8. The lands described in Schedule “G”, hereto attached, are hereby dedicated as a public highway and declared to form part of McCowan Road (YR 67).
9. The lands described in Schedule “H”, hereto attached, are hereby dedicated as a public highway and declared to form part of Mulock Drive (YR 74).
10. The lands described in Schedule “I”, hereto attached, are hereby dedicated as a public highway and declared to form part of Weston Road (YR 56).
11. The lands described in Schedule “J”, hereto attached, are hereby dedicated as a public highway and declared to form part of King Road (YR 11).
12. The lands described in Schedule “K”, hereto attached, are hereby dedicated as a public highway and declared to form part of Bathurst Street (YR 38).
13. The lands described in Schedule “L”, hereto attached, are hereby dedicated as a public highway and declared to form part of Bayview Avenue (YR 34).
14. The lands described in Schedule “M”, hereto attached, are hereby dedicated as a public highway and declared to form part of Bayview Avenue (YR 34) and Stouffville Road (YR 14).

15. The said Schedules “A”, “B”, “C”, “D”, “E”, “F”, “G”, “H”, “I”, “J”, “K”, “L” and “M”, hereto attached, shall form part of this by-law.
