BY-LAW NO. RD-0511-2004-024

To dedicate certain lands for
the purposes of public highways

WHEREAS the hereinafter described lands are vested in The Regional Municipality of York for highway purposes;

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The acquisition of the lands described in Schedules “A”, “B”, “C”, “D” and “E”, hereto attached, is hereby authorized, ratified and confirmed.
2. The lands described in Schedule “A”, hereto attached, are hereby dedicated as a public highway and declared to form part of Stouffville Road (YR 14).
3. The lands described in Schedule “B”, hereto attached, are hereby dedicated as a public highway and declared to form part of Elgin Mills Road East (YR 49).
4. The lands described in Schedule “C”, hereto attached, are hereby dedicated as a public highway and declared to form part of Major Mackenzie Drive West (YR 25).
5. The lands described in Schedule “D”, hereto attached, are hereby dedicated as a public highway and declared to form part of Jane Street (YR 55).

6. The lands described in Schedule “E”, hereto attached, are hereby dedicated as a public highway and declared to form part of Weston Road (YR 56).
7. The said Schedules “A”, “B”, “C”, “D” and “E”, hereto attached, shall form part of this by-law.

SCHEDULE “A” TO BY-LAW NO. RD-0511-2004-024

Lands in the Town of Richmond Hill in The Regional Municipality of York being Block C, Plan 578 (geographically in the Township of Whitchurch in the County of York).

SCHEDULE “B” TO BY-LAW NO. RD-0511-2004-024

Lands in the Town of Markham in The Regional Municipality of York (geographically in the Township of Markham in the County of York), being part of the east half of Lot 25, Concession 3, designated as Parts 1 and 2 on Expropriation Plan D885.

SCHEDULE “C” TO BY-LAW NO. RD-0511-2004-024

Lands in the City of Vaughan in The Regional Municipality of York (geographically in the Township of Vaughan in the County of York) more particularly described as follows:

Firstly: being part of the east half of Lot 21, Concession 5 designated as Part 1 on Plan 65R25957.

Secondly: being part of the east half of Lot 21, Concession 5 designated as Part 2 on Plan 65R25957.

Lands in the City of Vaughan in The Regional Municipality of York (geographically in the Township of Vaughan in the County of York) more particularly described as follows:

Firstly: being part of the east half of Lot 21, Concession 5 designated as Part 3 on Plan 65R25957.

Secondly: being part of the east half of Lot 21, Concession 5 designated as Part 4 on Plan 65R25957.

Lands in the City of Vaughan in The Regional Municipality of York being part of Block 35, Plan 65M3427 designated as Parts 1 and 2 on Plan 65R26387.
