BY-LAW NO. RD-0513-2004-056

To dedicate certain lands for
the purposes of public highways

WHEREAS the hereinafter described lands are vested in The Regional Municipality of York for highway purposes;

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The acquisition of the lands described in Schedules “A”, “B”, “C”, “D”, “E”, “F” and “G”, hereto attached, is hereby authorized, ratified and confirmed.
2. The lands described in Schedule “A”, hereto attached, are hereby dedicated as a public highway and declared to form part of Dufferin Street (YR 53).
3. The lands described in Schedule “B”, hereto attached, are hereby dedicated as a public highway and declared to form part of Woodbine Avenue (YR 8).
4. The lands described in Schedule “C”, hereto attached, are hereby dedicated as a public highway and declared to form part of Gamble Road (YR 29).
5. The lands described in Schedule “D”, hereto attached, are hereby dedicated as a public highway and declared to form part of Vivian Road (YR 74).

6. The lands described in Schedule“E”, hereto attached, are hereby dedicated as a public highway and declared to form part of 14th Avenue (YR 71).
7. The lands described in Schedule“F”, hereto attached, are hereby dedicated as a public highway and declared to form part of Kennedy Road (YR 3).
8. The lands described in Schedule“G”, hereto attached, are hereby dedicated as a public highway and declared to form part of Langstaff Road (YR 72).
9. The said Schedules“A”,“B”,“C”,“D”,“E”,“F” and“G”, hereto attached, shall form part of this by-law.
