BY-LAW NO. RD-0514-2004-071

To dedicate certain lands for
the purposes of public highways

WHEREAS the hereinafter described lands are vested in The Regional Municipality of York for highway purposes;

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The acquisition of the lands described in Schedules “A”, “B”, “C”, “D”, “E” and “F”, hereto attached, is hereby authorized, ratified and confirmed.
2. The lands described in Schedule “A”, hereto attached, are hereby dedicated as a public highway and declared to form part of Elgin Mills Road East (YR 49).
3. The lands described in Schedule “B”, hereto attached, are hereby dedicated as a public highway and declared to form part of Jane Street (YR 55).
4. The lands described in Schedule “C”, hereto attached, are hereby dedicated as a public highway and declared to form part of Ninth Line (YR 69).
5. The lands described in Schedule “D”, hereto attached, are hereby dedicated as a public highway and declared to form part of Teston Road (YR 49).

6. The lands described in Schedule “E”, hereto attached, are hereby dedicated as a public highway and declared to form part of Rutherford Road (YR 73).
7. The lands described in Schedule “F”, hereto attached, are hereby dedicated as a public highway and declared to form part of Leslie Street (YR 12).
8. The said Schedules “A”, “B”, “C”, “D”, “E” and “F”, hereto attached, shall form part of this by-law.

Part of Lot 26, Concession 2, in the Town of Richmond Hill in The Regional Municipality of York (geographically in the Township of Markham in the County of York), designated Part 1 on Expropriation Plan D872.

SCHEDULE “B” TO BY-LAW NO. RD-0514-2004-071

Lands in the Township of King in The Regional Municipality of York (geographically in the Township of King in the County of York), more particularly described as follows:

Firstly: Part of Lot 25, Concession 5, designated as Part 1 on Expropriation Plan D920; and

Secondly: Part of Lot 25, Concession 5, designated as Part 2 on Expropriation Plan D920.

Lands in the City of Vaughan in The Regional Municipality of York (geographically in the Township of Vaughan in the County of York), more particularly described as follows:

Firstly: Part of Lots 15 and 16 and part of the road allowance between Lots 15 and 16, Concession 8, designated as Part 2 on Expropriation Plan D890; and

Secondly: Part of Lot 16, Concession 8, designated as Parts 3, 4 and 5 on Expropriation Plan D920.
