BY-LAW NO. RD-0517-2005-014

To dedicate certain lands for
the purposes of public highways

WHEREAS the hereinafter described lands are vested in The Regional Municipality of York for highway purposes;

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The acquisition of the lands described in Schedules “A”, “B”, “C” and “D”, hereto attached, is hereby authorized, ratified and confirmed.
2. The lands described in Schedule “A”, hereto attached, are hereby dedicated as a public highway and declared to form part of Elgin Mills Road East (YR 49).
3. The lands described in Schedule “B”, hereto attached, are hereby dedicated as a public highway and declared to form part of Warden Avenue (YR 65).
4. The lands described in Schedule “C”, hereto attached, are hereby dedicated as a public highway and declared to form part of Dufferin Street (YR 53).

5. The lands described in Schedule “D”, hereto attached, are hereby dedicated and established as a public highway and declared to form part of Woodbine Avenue (YR 8).
6. The said Schedules “A”, “B”, “C” and “D”, hereto attached, shall form part of this by-law.

SCHEDULE "A" TO BY-LAW NO. RD-0517-2005-014

Lands in the Town of Markham in The Regional Municipality of York, geographically in the Township of Markham in the County of York, more particularly described as follows:

Firstly: Part of Lot 26, Concession 3, designated as Parts 1 and 2 on Expropriation Plan D858;

Secondly: Part of Lot 26, Concession 3, designated as Part 1 on Expropriation Plan D877; and

Thirdly: Part of Lot 26, Concession 3, designated as Part 3 on Expropriation Plan D877.

SCHEDULE "B" TO BY-LAW NO. RD-0517-2005-014

Part of Lot 6, Concession 4, in the Town of Markham in The Regional Municipality of York, geographically in the Township of Markham in the County of York, designated as Parts 1, 2, 3, 6, 7, 8 and 9 on Expropriation Plan D849.

SCHEDULE "C" TO BY-LAW NO. RD-0517-2005-014

Lands in the Township of King in The Regional Municipality of York, geographically in the Township of King in the County of York, being Part of Lot 12, Concession 2 as in B60599B.

SCHEDULE "D" TO BY-LAW NO. RD-0517-2005-014

Lands in the Town of Markham in The Regional Municipality of York, geographically in the Township of Markham in the County of York, more particularly described as follows:

Firstly: Part of Block 6 (reserve), Plan 65M2044, designated as Part 1 on Plan 65R26823; and

Secondly: Part of Block 1, Plan 65M2044, designated as Parts 1, 5 and 7 on Plan 65R26104.
