BY-LAW NO. RD-0520-2005-093

To dedicate certain lands for
the purposes of public highways

WHEREAS the hereinafter described lands are vested in The Regional Municipality of York for highway purposes;

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The acquisition of the lands described in Schedules “A”, “B”, “C”, “D”, “E”, “F” and “G”, hereto attached, is hereby authorized, ratified and confirmed.
2. The lands described in Schedule “A”, hereto attached, are hereby dedicated as a public highway and declared to form part of Ninth Line (YR 69).
3. The lands described in Schedule “B”, hereto attached, are hereby dedicated as a public highway and declared to form part of Major Mackenzie Drive East (YR 25).
4. The lands described in Schedule “C”, hereto attached, are hereby dedicated as a public highway and declared to form part of Highway 7 (YR 7).

5. The lands described in Schedule “D”, hereto attached, are hereby dedicated as a public highway and declared to form part of Weston Road (YR 56).
6. The lands described in Schedules “E” and “F”, hereto attached, are hereby dedicated as a public highway and declared to form part of Rutherford Road (YR 73).
7. The lands described in Schedule “G”, hereto attached, are hereby dedicated as a public highway and declared to form part of Bayview Avenue (YR 34).
8. The said Schedules “A”, “B”, “C”, “D”, “E”, “F” and “G”, hereto attached, shall form part of this by-law.
