BY-LAW NO. RD-0529-2006-114

To dedicate certain lands for
the purposes of public highways

WHEREAS the hereinafter described lands are vested in The Regional Municipality of York for highway purposes;

Now, therefore, the Council of The Regional Municipality of York HEREBY ENACTS as follows:

1. The acquisition of the lands described in Schedules “A”, “B”, “C”, “D” and “E”, hereto attached, is hereby authorized, ratified and confirmed.
2. The lands described in Schedule “A”, hereto attached, are hereby dedicated as a public highway and declared to form part of Regional Road No. 48 (Y.R. 48).
3. The lands described in Schedule “B”, hereto attached, are hereby dedicated as a public highway and declared to form part of Ninth Line (Y.R. 69).
4. The lands described in Schedule “C”, hereto attached, are hereby dedicated as a public highway and declared to form part of Highway 7 (Y.R. 7).
5. The lands described in Schedule “D”, hereto attached, are hereby dedicated as a public highway and declared to form part of King Road (Y.R. 11).
6. The lands described in Schedule “E”, hereto attached, are hereby dedicated as a public highway and declared to form part of Warden Avenue (Y.R. 65).

7. The said Schedules “A”, “B”, “C”, “D” and “E”, hereto attached, shall form part of this by-law.

Lands in the Town of Markham in The Regional Municipality of York, geographically in the Township of Markham in the County of York being part of Lots 16 and 17, Concession 9, designated as Part 1 on Expropriation Plan D958.

SCHEDULE "B" TO BY-LAW NO RD-0529-2006-114

Lands in the Town of Markham in The Regional Municipality of York, geographically in the Township of Markham in the County of York, more particularly described as follows:

Firstly: Part of Lot 17, Concession 9, designated as Part 4 on Expropriation Plan D839; and

Lands in the Township of King in The Regional Municipality of York, geographically in the Township of King in the County of York being part of Lot 5, Concession 10, designated as Part 7 on Plan 65R28365.

SCHEDULE "E" TO BY-LAW NO. RD-0529-2006-114

Lands in the Town of Georgina in The Regional Municipality of York, geographically in the Township of North Gwillimbury in the County of York, more particularly described as follows:

Firstly: Part of Lot 1, Concession 4, designated as Parts 1 and 2 on Plan 65R25992; and

Secondly: Part of Lot 1, Concession 5, designated as Part 9 on Plan 65R25992.
