RE: **Re-organization of the Community and Health Services Department**

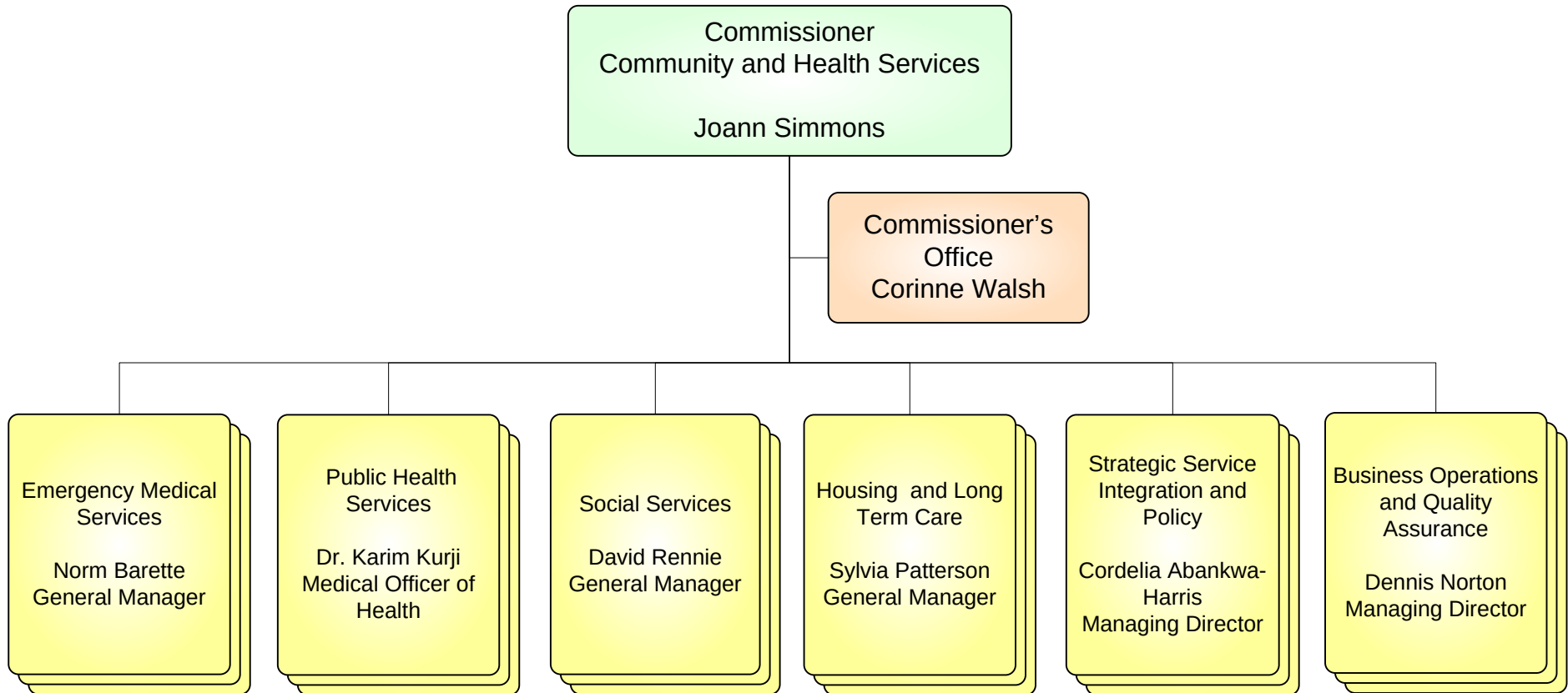
Following Regional Council's approval of the formation of the Community and Health Services Department and the retirement of several management staff, the department has been re-organized.
